CANCELLATION AND REFUND POLICY

Your Membership expires October 31st of each year. If you cancel your membership prior to October 31st, you will not be allowed to become a Member again until one full year has passed since the expiration of your previous membership unless the cancellation was due to a disability or you moved your residence more than 10 miles from the Fitness Center. Any cancellation of membership will take effect the first day of the following month after the date cancellation is requested. If you paid your membership fee in advance, the unused portion of your membership fee will be refunded to you. You can become a member again anytime before the one year has passed by paying all membership fees you would have paid had you not cancelled your membership.

Titonka Fitness Center Rules

- No one under the age of 14 may be in the Fitness Center.
- Persons under the age of 18 may not use the facility from 10:00 p.m. to 5:00 a.m.
- 14-17 year olds must be accompanied by an adult.
- 14 - 17 year olds may not purchase a single membership.
- You must notify City Hall or Titonka Recreation Commission Board Member if your access key is lost or stolen.
- If you discontinue membership, your access key(s) must be returned to City Hall or a Titonka Recreation Commission Board Member within 15 days from the date your membership expired or you will lose your key deposit.
- Allowing non-members into the facility is prohibited.
- Your membership may not be used by or assigned to another person.
- Please refrain from using the facility if you have reason to believe that you are carrying a communicable disease, such as a cold or flu, and properly cover any abrasions or lesions on skin that may come in contact with equipment.
- When another Member is waiting for the machine you are using, please limit your use to 30 minutes.
- Clean up after yourself and put trash in the wastepaper basket.
- No food of any kind is allowed in the facility.
- Each Member is responsible for proper use of exercise equipment. All equipment should be cleaned by the Member after each use and returned to its original settings and position.
- Any equipment or other property damaged or destroyed due to the negligence or willful misuse of the Member will be repaired or replaced at the Member's expense and may result in loss of Membership.
- All exercises including the use of weights and use of any and all machinery, equipment and apparatus designed for exercising shall be at the Member's sole risk.
- The Titonka Fitness Center, Titonka Recreation Commission and the City of Titonka are not responsible for accidents. Please refer to the Waiver and Release of Liability form for details.
- Please change your shoes before using the equipment. Outside elements (snow, mud, dirt, sand, rain, etc.) can damage the equipment.
