Motion was made by Hamilton and seconded by Harms to set a policy for use of the Buffalo Creek Activity Center for benefits, allowing 50% off the regular rental price if the benefit is for a resident of the City of Titonka. Motion was made by Harms and seconded by Zwiefel to approve the purchase of a new master meter for the gas plant, at a cost not to exceed \$2, 600.00. 4 ayes, 0 nays, 1 absent. Motion carried.

Motion was made by Zwiefel and seconded by Hamilton to approve the Annual Urban Renewal Report for FY 2017-2018. 4 ayes, 0 nays, 1 absent. Motion carried.

Motion was made by Zwiefel and seconded by Harms to certify to the county auditor, \$33,891.06, in new debt incurred as eligible urban renewal projects, as outlined in Amendment #1 to the Titonka Economic Development District Urban Renewal Plan, to be repaid with tax increment financing. 4 ayes, 0 nays, 1 absent. Motion was made by Zwiefel and seconded by Lague to accept the quote for the Itron Maintenance Renewal, at a cost of \$1,536.00. 4 ayes, 0 nays, 1 absent. Motion carried.
