Motion was made by Hamilton and seconded by Etherington to hire Amanda Higgins as Swimming Pool manager, Elizabeth Carlton as Assistant Manager, and Ashley Higgins and Kristen Schutter as full-time lifeguards. 5 ayes, 0 nays. Carried.
