Titonka City Council met in regular session Thursday, February 6, 2014 at 7:00 P.M. at City Hall.

Meeting was called to order by Mayor Boyken with council members Hamilton, Lee and Zwiefel present. Etherington and Johnson absent. Also attending were Kelly Evans with I&S Group, Marty Fonley, Gloria Bartelt, Gabrielle Trunkhill, Deb Harms, Paul Jahnke, and Clerk Karen Hamilton.

Marty Fonley, Algona School Superintendent, and Gloria Bartelt, Gabrielle Trunkhill and Deb Harms, Titonka School Board members, met with the council to discuss the Titonka School building.

Kelly Evans with I&S Group gave an update on the sewer project. The surveying and preliminary planning is approximately 95% complete.

Motion was made by Zwiefel and seconded by Hamilton to set publication date for February 19th and the Public Hearing date for March 6, 2014 at 7 P.M. for the proposed FY2014-2015 budget.
