Motion was made by Watkins and seconded by Harms to approve the proposed street repairs from Heartland Asphalt, at a price not to exceed \$60,000.00. 3 ayes, 0 nays, 2 absent. Motion carried.

Motion was made by Trunkhill and seconded by Harms to retain Paul Jahnke for on call status, at the rate of \$100 per day. 3 ayes, 0 nays. Motion carried.

Motion was made by Harms and seconded by Watkins to offer the City Clerk position to Rachel Kurtzleben. 3 ayes, 0 nays. Motion carried.
